Creating an independent global mechanism to document and expose all violations of the proposed treaty.

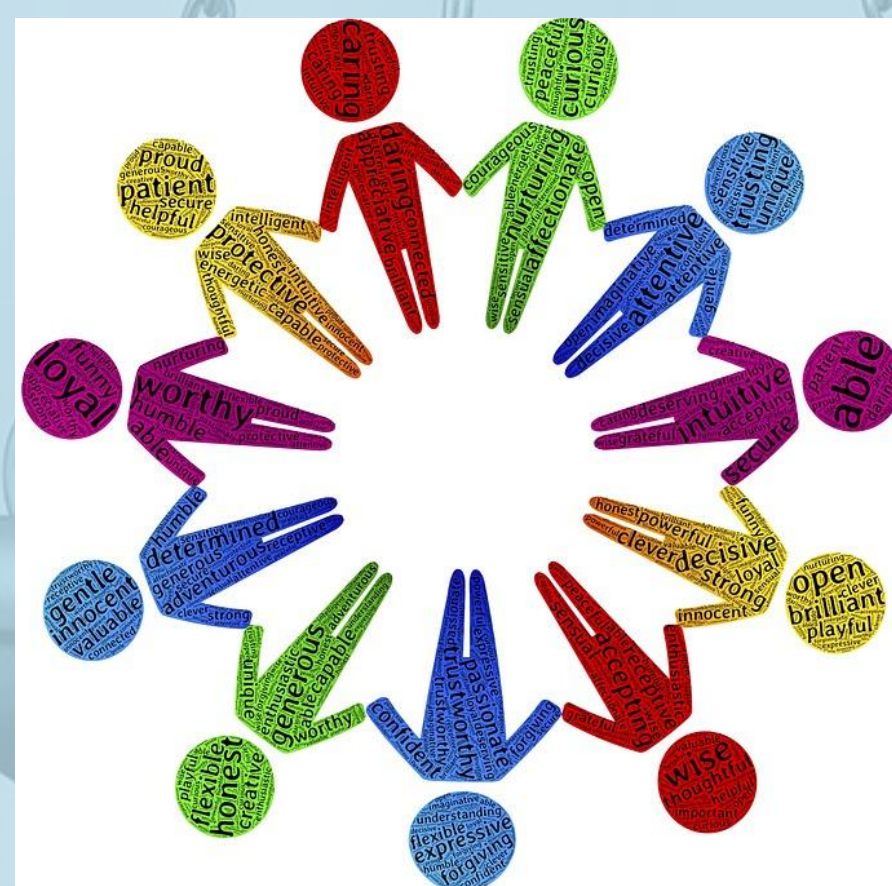

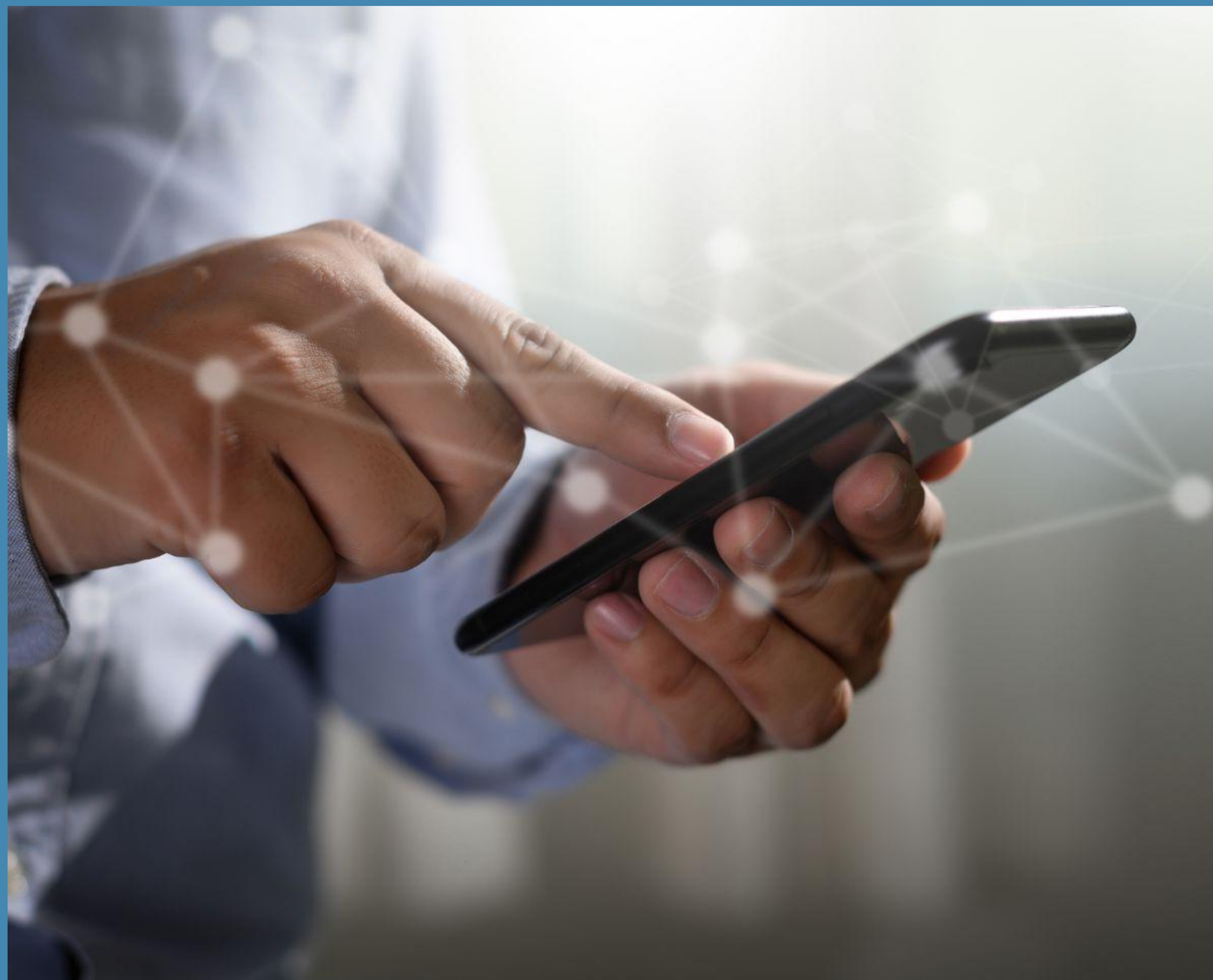

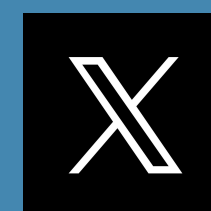
