This initiative is a growing international process bringing together prominent officials, lawmakers, philanthropists and international stakeholders to address the root causes of religious conflict and discrimination worldwide.

It seeks to move beyond traditional dialogue by advancing a clear, practical and widely acceptable international legal framework that protects the sanctity of religion from political exploitation and strengthens equality, stability and social cohesion.

The proposed treaty introduces focused and non-confrontational standards to address:

- Political abuses of religion that undermine human equality.
- Religious discrimination in rights and duties.
- Religious exclusion in public law and governance.
- Restrictions on freedom of religion or belief arising from political instrumentalisation.

These respectful, universal and preventive standards are designed to build global consensus and provide a constructive pathway to strengthen equality and stability worldwide.

**Strategic Objectives – Advancing a Practical International Framework**

The initiative aims to support the development of a practical global framework to strengthen the international legal toolkits relating to equality, stability and freedom of religion or belief.

This process seeks to:

- Address drivers of religious conflict and discrimination.
- Advance practical and focused international standards.
- Strengthen the international legal toolkit to enhance global cohesion.
- Reinforce long-term stability and responsible governance.
- Promote constructive international cooperation.

The initiative is now under active consideration by several governments for state adoption following recognition at the Council of Europe and the adoption of the Westminster Declaration at a conference in the UK House of Commons.
